Subject: Unauthorized Third-Party Recertification Shops and Certificates for Coiled Tubing and Wireline Pressure Control Equipment

1. PURPOSE

This communication is issued to create awareness and provide clear guidance regarding unauthorized third-party shops making **misleading statements** about the recertification of **coiled tubing and wireline pressure control equipment within their certificates**. These claims pose potential safety risks and misrepresent our company's standards.

2. ISSUE SUMMARY

It has come to our attention that various third-party service providers—**not affiliated with or authorized by FET (VAN/AMT)**—are issuing **statements within their reports and certificates** indicating that their:

- 5-year recertification services meet all manufacturer specifications, and
- Equipment is within acceptable tolerances as per our standards.

These statements are **false and misleading**. These shops are **not part of our Global Recertification Program** and have **no commercial relationship** with **FET (VAN/AMT)**.

3. ROOT CAUSE

The root cause of this issue is the **unauthorized use of manufacturer references** by third-party shops attempting to validate their services by **falsely claiming compliance** with OEM (Original Equipment Manufacturer) standards.

Key contributing factors include:

- Lack of awareness by customers and field operators regarding authorized vs. unauthorized providers
- Misuse of language that implies approval or certification from **FET** (**VAN/AMT**)
- The absence of legal or technical scrutiny on issued reports in the field

4. OUR POSITION

FET (VAN/AMT) is the **sole entity authorized to perform and issue valid recertification certificates** for our coiled tubing and wireline pressure control equipment.

Any recertification certificate not issued directly by FET (VAN/AMT) or one of our authorized service centers is invalid.

These unauthorized certificates:

- Do not meet our quality, safety, or engineering requirements
- May lead to equipment malfunction or safety failure
- **FET** (VAN/AMT) does not recognize any work performed by non-authorized service providers, and such work is not eligible for compliance support

5. IMPORTANT INFORMATION FOR OUR VALUATED CUSTOMERS

- Do not accept recertification documentation from non-authorized third-party shops.
- Verify any certification or service reports by contacting FET (VAN/AMT) directly.
- Partner with **FET** (VAN/AMT) to ensure your Procurement and HSE teams have the resources and guidance needed to identify valid documentation from authorized providers.
